The Reminder Email Notice

The form of the Reminder Email Notice attached as *Exhibit A* to the Motion is approved. The Settlement Administrator shall complete the process of sending the Reminder Email Notices to those members of the Settlement Class who were sent an Email Notice and have not yet submitted a Claim Form by no later than 45 days after this Order.

Modified Final Approval Schedule

The Final Approval Hearing date is rescheduled for July 24, 2024, and in conjunction with that change in the schedule, the Court orders the following changes to the schedule preceding that hearing, including extending the current deadlines set by the Preliminary Approval Order:
